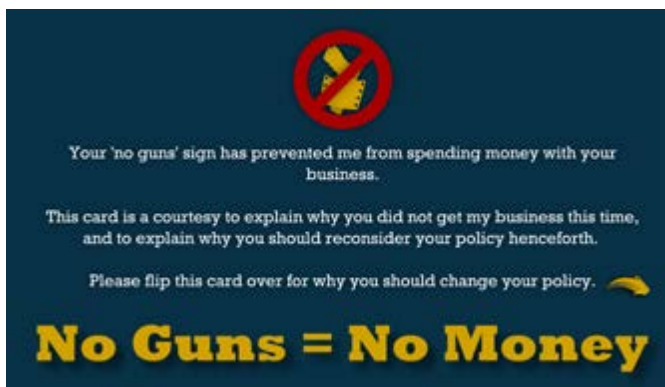


Campaign Spotlight

No Guns = No Money

As Connecticut Carry's most popular Sustainable Campaign to date, No Guns = No Money is doing very well. The goal of a sustainable campaign is to create an ongoing program that supports itself financially, and funds future growth. No Guns = No Money has the additional goal of making it clear to business owners that they should not only not ban firearms from their premises, but that they should actually welcome and prefer people who possess pistol permits and carry firearms.

This work actually reaps multiple benefits. We resist the tendency of businesses that mindlessly post policies and signs that forbid guns. We also spread awareness, that people all over the state carry firearms while performing their daily business, and that these armed citizens harm no one. The fact is, many people, including business owners, have no idea how many people have firearms on them on a daily basis. They have no idea that approximately 1 in 10 people in Connecticut have a carry permit, of those citizens who are not otherwise prohibited from having one. It is in our best interest to make sure that as many people as possible know our numbers and our excellent track record of peaceful living.



We started the No Guns = No Money campaign with business cards. On one side, the cards tell business owners that the person handing them the card has decided to avoid doing business with them because of the posted anti-gun policy or signage. The other side of the card lists the qualifications for someone to obtain a legally held Connecticut Permit to Carry Pistol or Revolvers. The No Guns = No Money card also poses the important question "What do you know about your other customers?".

So, how is the campaign doing so far? We publish our numbers for all of our merchandise, including our Sustainable Campaign merchandise in our monthly director meeting minutes. You can download these through our website, when you login with your member credentials that you created when you first joined our site.

Based on our September meeting minutes, in August and Septem-

ber alone, we sold 1,625 cards for a value of \$169.26. Since the start of the campaign, we have sold 4,125 cards

for a total revenue of \$429.83. So far, we have only spent \$147.83 on the campaign which results in the campaign having \$282.00 to be spent on restocking and growing the campaign. We still have almost 3,000 cards left in stock. We will not likely be reordering the business cards in the next month or two. We have time and money to expand the campaign.

What's the best plan to expand the campaign? Our current plan is to expand on the current messaging of the campaign, by creating larger formats of the business cards, possibly as postcard sized handouts. We are also considering an online tool that would allow our members to send postcards directly from Connecticut Carry to business owners that have these kinds of policies. The tool development will take longer to roll out, but we can easily get the postcards ready and available

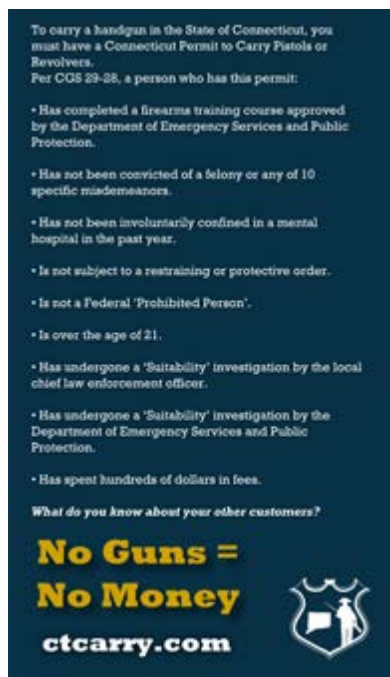
for our members to hand out individually, in the interim.

We will be introducing a program to help our members recognize and find Connecticut Carry Friendly businesses. This will likely consist of window decals that business owners can post instead of 'No Guns' signs. We also want to have

Honey, I'm Being Attacked! Where Did We Stash the Bug Spray?!!

Politicians and special interests groups often have a way of saying the most ludicrous things, such as telling rape or assault victims to go looking for call boxes on college campuses, or to blow a whistle during a surprise violent attack, or to try to find the household bug spray to ward off attackers in one's home, or in the extreme, to allow violent attackers to have their way with the victim! Shame on those who tell honest decent people to allow violent criminals to go ahead and abuse them! but rather hold the drunk responsible. By contrast, that same logical conclusion is NOT applied to the abuse of firearms by violent criminals. Instead of holding the criminals responsible for their actions, the “politically correct”, anti-Rights, anti-arms crowd ignorantly holds firearms responsible, a wholly illogical and irresponsible

way of dealing with the issue. As a result of that illogical and irresponsible discrepancy between the way firearms and motor vehicle abuses are handled, the ongoing

end result is that only law-abiding citizens are the ones penalized when firearms are abused by criminals. Instead of dealing with the real issues of sin, crime, and punishment, the politicians make false and misleading promises that continue to fail to address the causes of violent crime or the need for godly punishment of violent criminals.

Most of us know that the current anti-Rights, anti-firearms, political climate seeks to disarm law-abiding U.S. citizens, as well as citizens of other nations around the world. That political mal-intent toward law-abiding citizens must surely cause violent criminals to applaud further attempts to pass more gun control laws. ALL law-abiding citizens MUST work together to

reverse the anti-gun laws that have so egregiously deprived us of our Right to choose what weapon we want to protect ourselves. Many may seek to argue the merits of some particular weapon or other, yet according to our Constitution our Rights secured by our Constitution and Bill of Rights are NOT to be infringed at all. What is so hard to understand about "shall not be infringed"?

There is no time for laziness. There is no time for silence. There is no time for uncertainty or fear. We must all work to return to the Law of the Land as it has been established in our Constitution and our Bill of Rights, the firearms Rights of which were affirmed under the slavery supporting Dred Scott Decision. Though that Decision violated the man's Human Rights, and left him a slave without citizenship, yet it affirmed the premise of the universality of our Second Amendment across our Nation, for the latter was used as justification for denying his citizenship. I've said this before, in other ways and venues, and I shall repeat it as often as necessary, we may be ostracized

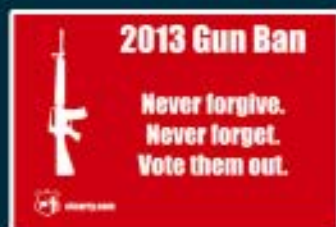

Announcing the Connecticut Carry Members Forum

It has been a long time in the making, but we are proud to announce that the Connecticut Carry Members Forum is open for members. When we first started the project, we had a lot of different ideas and concepts about what we wanted the forum to be. The one central idea that we kept coming back to was that we wanted the best place in Connecticut to ask questions and get answers from the most knowledgeable people in Connecticut on self-defense, firearms and the laws surrounding both. We also want to encourage thoughtful and factual discussions on cur-

rent issues, as well as provide our members a place to build a strong community, and coordinate volunteer and activist activities.

Since our primary goal is a place for high quality questions and answers, that is how we designed the forum. We believe the other goals are also handled by the same software and that our members will find the site very useful for these purposes.

The forum software is not like your 'standard' forum. Instead, it is built to provide a better experience for people seeking quality answers. To that end, forum members

will be able (and encouraged) to vote on answers and questions alike. This voting helps the best questions and answers float to the top so that people who have the same questions get the correct high quality answers in a hurry.

One of the problems that occurs on other forums that have similar subject matter is that you must read page after page of discussion to try and determine the correct answer, but there is no indication other than your own intuition as to who is providing good information and who has a reputation of being trustworthy. This has resulted in other forums allowing the noise of bad advice from less-than-desirable people to rise to the top. Our forum's voting system allows for a ranking in reputation points for each user. Over time, people who contribute lots of valuable input and back their assertions up with facts should gain lots of reputation, while people who try to spread misinformation or make unfounded statements will lose reputation and eventually fade away.

One goal of the forum is to have minimal intervention from moderators. We have, however, had three members step up and volun-

or even killed for sticking out our necks and getting involved in the defense of our constitutional Rights, but we are already dead if we do not get actively involved in the defense of our Rights.

If we do not succeed in turning around our Nation and our states, then not only shall we suffer the dire consequences of increased violent criminal activity, but our whole social structure shall continue to deteriorate. Despite all the bug spray and other weapons of opportunity they might muster, in a society devoid of souls willing to keep and to bear personal firearms for self-defense and in defense of our states and nation, even those persons or entities which now call for the removal and destruction of our arms and Rights will find themselves easy pickings and ready victims for violent criminals, as violent criminals never have significant problems finding violent ways to perpetrate their crimes against persons, property, and society. We, law-abiding citizens, **MUST** get active and stay active in support and defense of our Constitution and our Bill of Rights, and of ourselves. Without our constructive actions, the USA shall decline into deeper political and social totalitarianism.

Remember that more than **EIGHTY YEARS** of U.S. anti-gun laws have **NOT** stopped violent

criminals from obtaining firearms and other means of perpetrating violent crimes, as they have desired. Remember that those very anti-firearms laws have only served to make it more difficult for decent, law-abiding citizens to defend themselves and their loved ones. Don't delay! Get active today! Our today and tomorrow, and that of our loved ones, depend on you and me doing what our Constitution and Bill of Rights says we are supposed to do as U.S. citizens, ...now, ... and for the rest of our lives. This is **NOT** a one shot deal. Those who wish to read a detailed scientific discussion of the relationships between firearms ownership and violent crime will appreciate John R. Lott's "More Guns, Less Crime". The book is based on longitudinal and cross-sectional study and analyses of crime and gun laws across the USA, while Lott was affiliated with the University of Chicago's School of Economics.

4. We can join more than one such organization, as the increased numbers of voices and focus groups not only encourage one another, but also amplify the voice of our mutual cause to politicians and officials currently in power or running for office.

5. We can contribute financially to one or more of the groups that we have found constitutionally sound, whether we have joined them or not. The more cash that is in the treasuries of Constitution supporting and defending organizations and candidates, the more positive impact they will have to ward off the attacks of the Constitution destroyers.

6. We can make one-time or regular donations to the Constitution defense groups and candidates with which we agree. They are always grateful for the help. Committing ourselves to being regular financial supporters of our constitutional cause means that more money can go toward doing the work of protecting our Constitution, and less

7. Whether we display group or candidate signs, hats, T-shirts, flags, yard signs, or whatever, remember that our objective is NOT to scare people into submission but to educate them and confirm to them that we are exercising the

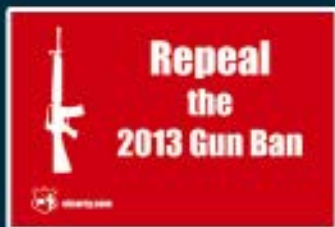

As we have [released previously](#), and for the reasons we state there, we will not be endorsing candidates for office. Are We Going To Lose This Election?

No one wants to be the one to say it. Connecticut Carry sure doesn't want to have to be the ones to have to say it. But we are in serious risk of losing this election. We have Malloy on the run with poll numbers from Malloy-friendly polling institutes that cannot hide the fact that Connecticut residents hate Governor Dannel Malloy and his policies and favor Republican challenger Tom Foley.

So how can we lose?

We have a contingent of people who have decided that 'principle' and 'rights' mean more to them than the basic common sense of voting the worst anti-rights governor in the nation out. Now, let's be clear here: We support and stand on principles and rights more than any organization in Connecticut. In a [recorded video](#) that he made, he stated unequivocally that he believes that since a Bridgeport officer negligently discharged a round through the glass window of the bagel shop, where he was sitting, the solution should be that officers state-wide be mandated to carry unloaded firearms. He went on to say that, if he were governor, he would make that policy happen. What would then happen if/when there were a mass shooting under his administration? His thought pattern, about penalizing every innocent person for the stupid actions of one person, does not bode well for the law-abiding citizens of Connecticut. Visconti's logic is the

same logic used by anti-pol-like Gov-er- ti-rights iticians



nor Malloy.

Unfortunately, Visconti's most adamant supporters have decided to hold this election hostage, with many of them openly stating their belief that if Visconti does not win then we all deserve Malloy and the consequences that will come from Malloy's re-election. This hostage-election situation makes Visconti's campaign nothing less than a torpedo aimed, under false colors, trying to sink Foley, instead of sinking the anti-Rights regime of Malloy. It is almost as if Visconti is deliberately trying to help Malloy win and float away unscathed. Visconti claims to want citizen Rights restored, yet he continues to allow Malloy to flatter him and encourage him, knowing all the while that he, Visconti, cannot win this race for Governor. How can Visconti claim to have the interests of citizen Rights at heart, when he continues to play into the hands of an-

ti-Rights Malloy? Visconti's in-temperate ego and illogical stubbornness has caused many people to wonder whether the Visconti campaign might actually be run by the Malloy campaign. While that is only idle speculation, without any evidence, one thing is for certain, the Visconti campaign is not about 'gun rights' or the right to bear arms, it is about him as an individual candidate who does not have the best interests of Connecticut residents in mind. From where we view this, Visconti, for his own personal gain, is exploiting his supporters who yearn for the unfringed right to self-defense.

Normally, such a third person campaign would not be great concern. However, Visconti's support has been variously polled at 9%. Despite the ridiculously low number that 9% represents, in most elections; in the context of THIS election, that 9% may be more than enough to hand the election to Governor Malloy. In the last election, Tom Foley only lost by 6%. According to the various polls, this race is shaping up to be an even closer one. Worse still, Visconti has somehow convinced himself and his supporters that, although he is polling at 9% (or less), they think and believe that he is not just capable of winning the election, but they insist that he is likely to win the election. Wishful

thinking is nothing new in politics, but in this case,



the wishful thinking of Visconti and his supporters may well cause the sounding of the death knell for our constitutional Rights in this state.

For months Connecticut Carry has been discussing the likely ramifications of Malloy's re-election. If Malloy is re-elected, there will be nothing that anyone can do to slow the collectivist march of the anti-rights organizations and politicians. IF Malloy is re-elected, we may well expect that he will try to push for the complete denial and excision of the Right to carry a firearm, even going so far as to try to have our Constitution re-written to remove Section 15. So, if we can't, won't, or don't oust Malloy in this election, do NOT be surprised at his next drastic anti-Rights, anti-gun policy focus. Losing the Right to carry a firearm is the area where we have the most to lose.

For pro-Rights citizens, the simple truth of this election is the

question of, how can we remove Governor Dannel Malloy from office? For pro-Rights people, this is an absolute must. We are already burdened by unconstitutional and grievous gun laws. IF we endure the Visconti-made schism among pro-Rights voters, we also must face the distinct possibility of a Malloy win. A Malloy win would certainly bring about a most horrible flood of gun laws that would even more drastically hurt our way of life, worse than any of us have imagined, until now.

Although most of us now recognize the need for Visconti to drop out of the race and to support Foley, there is, still, a small contingent of people who persist in asking questions like 'What do we know about Tom Foley'? Most importantly, we KNOW that Foley is NOT Governor Malloy. We KNOW that Foley has not gone out of his way to infringe upon the Rights of citizens, as Malloy has done. We also KNOW that the STRONGEST message we can send to politicians, and the anti-gun crowd, is to remove Governor Malloy from office. And, we KNOW that Tom Foley is polling at 50+%, with Dannel Malloy teetering at about the same level. Therefore, we KNOW that Tom Foley is the only candidate who stands ANY CHANCE of being elected to oust Malloy, if we do

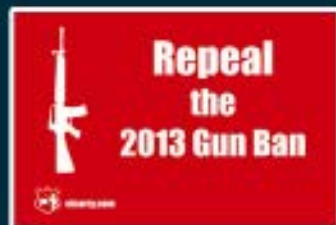

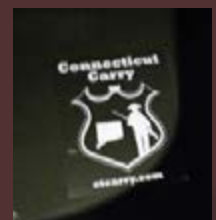

No Guns = No Money Drop Cards

The goal is to show these businesses that there are people who carry firearms or who simply support the right to carry a firearm who will not do business there because of their policy.

Until now, these businesses had no way to know that they were losing our business or why. They also had no argument presented about why they should change their policy.



To carry a handgun in the State of Connecticut must have a Connecticut Permit to Carry Pistol/Revolvers.

Per C.G.S. 29-28, a person who has this permit:

- Has completed a firearms training course as required by the Department of Emergency Services and Public Protection.

- Has not been convicted of a felony or any of specific misdemeanors.

- Has not been involuntarily confined in a mental hospital in the past year.

- Is not subject to a restraining or protective order.

- Is not a Federal "Prohibited Person".

- Is over the age of 21.

- Has undergone a "Suitability" investigation by a chief law enforcement officer.

- Has undergone a "Suitability" investigation by the Department of Emergency Services and Public Protection.

- Has spent hundreds of dollars in fees.
